- Personal identification information (Name, email address, phone number)
- Company identification information (Company name, company website, company phone number, company VAT number and P.IVA if applicable)
- Anonymous website and application usage data.

How do we collect your data?

You directly provide Mission Recycling with most of the data we collect. We collect data and process data when you:

- Use or view our website via your browser’s cookies.

The right to access – You have the right to request Mission Recycling for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Mission Recycling correct any information you believe is inaccurate. You also have the right to request Mission Recycling to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Mission Recycling erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Mission Recycling restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Mission Recycling's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Mission Recycling transfer the data that we have collected to another organization, or directly to you, under certain conditions.

We may also share online data collected through cookies with our advertising partners.
